PRESBYTERIANS GATHER IN NYC TO PROMOTE IMMIGRATION REFORM

New York, NY – April 17, 2007, 4:00 p.m. As New York City celebrates "Immigrant History Week," Presbyterians who live in and near the city hope to shape the future of US immigration. On Saturday, April 21, they will host an all-day conference on "Immigration, Justice and Christian Hospitality." All are invited! The sponsors hope that stirring speeches from the pulpit, roll-up-your-sleeves workshops on advocacy and immigrant services, and joyful worship in the sanctuary of the Fifth Avenue Presbyterian Church will strengthen the spirit of America on behalf of a compassionate and just reform of immigration laws. The conference is also designed to help individuals and congregations develop ministries that meet the needs of new immigrants, and to provide new immigrants with helpful information and resources.

FAQ's About the Conference:

When and where will the conference be held? The conference "Immigration, Justice and Christian Hospitality" will be held at the Fifth Avenue Presbyterian Church (FAPC), 7 West 55th Street, New York, New York 10019. Please enter through the 7 West 55th Street entrance. The conference will be held on Saturday, April 21, 2007, from 9:00 a.m. until 4:00 p.m.

Who will speak at the conference? Julia Thorne, Esq., Immigration Counsel and Manager for Immigration Issues for the Presbyterian Church (USA), will speak about the history of the church's efforts on immigration reform, and on the human cost of doing nothing in the present situation. Deborah J. Notkin, Immediate Past President of the American Immigration Lawyers Association, will speak about the prospects for comprehensive immigration reform in Congress.

Who will lead worship at the conference? Rev. Paul Rock, FAPC Associate Pastor, will give a welcome. Rev. Agnes Blackmon, Interim Associate Executive Presbyter for Congregational Ministry and Nurture, Presbytery of New York City (PC (USA)), will preach at the closing worship service.
