This two-day training will review selected issues in family-based immigration law, including establishing qualifying relationships for family-based petitions, inadmissibility grounds and waivers, adjustment and consular processing procedures, new affidavit of support regulations, and ethics. On April 18, supervisory staff from the National Benefits Center will do a presentation about Service Center policies and procedures, including a question and answer session with training participants. The trainers for this program are CLINIC attorneys Susan Schreiber of Chicago and Jennie Guilfoyle of New York, and attorney Suzanne Gladney of Legal Aid of Western Missouri.
