This training will review common grounds of inadmissibility, including health, crimes, fraud, smuggling, and prior immigration violations, and will provide guidance on preparing and documenting waiver applications. This training is interactive, with large and small group exercises on determining inadmissibility and preparing and submitting waiver applications.
