

About the Speakers

Jeff Joseph (Discussion Leader) is senior partner of Joseph Law Firm, PC. He is a graduate of the University of Denver, College of Law. He is a past Chapter Chair of the Colorado Chapter of the American Immigration Lawyers Association (AILA) and currently serves as an elected director on the AILA National Board of Governors. He has been qualified as an expert witness before the state and federal courts on employment-related and criminal-related immigration issues, and is a frequent local and national lecturer on various immigration topics. Mr. Joseph has been a speaker at the annual AILA conferences every year since 2001, and he has also addressed numerous other regional and state immigration conferences. Mr. Joseph has represented clients before the United States Citizenship and Immigration Service, the Executive Office for Immigration Review, the Board of Immigration Appeals, the U.S. District Courts, and the Circuit Courts of Appeals, and has published several opinions in those courts. He is an adjunct professor of immigration law at the University of Denver, College of Law. Mr. Joseph is bi-lingual in Spanish and English. Mr. Joseph heads up the employment-based immigration section and works primarily on employment based immigration cases, employer sanctions and federal litigation.

Andres Benach is partner in Duane Morris LLP. Mr. Benach practices in the area of immigration law, concentrating his practice on litigation matters before the federal courts and the immigration courts, specifically in complex matters regarding removability, inadmissibility, citizenship and the immigration consequences of criminal convictions. Mr. Benach has over ten years of experience handling sensitive, complex and challenging matters involving naturalization, asylum, complex removal, adjustment of status, federal litigation and waivers of inadmissibility. Mr. Benach was the inaugural chair of the American Immigration Lawyers Association Washington, D.C. Chapter Litigation Committee in 2007 and co-chairs the committee in 2008 with Thomas Ragland. Mr. Benach is a 1998 cum laude graduate of George Washington University Law School and a graduate of Boston College. Mr. Benach is fluent in Spanish.

Ally Bolour has been practicing immigration law since 1996 when he was admitted to the California State Bar. Mr. Bolour graduated from Southwestern University School of Law, in Los Angeles, California with a Juris Doctor. He is a member of the American Immigration Lawyers Association, the Los Angeles County Bar Association, and the Los Angeles Gay and Lesbian Lawyers Association. Previously, he was the Co-Chair, of the Beverly Hills Bar Association, Immigration Law Section in 1999/2000 and since 1998, continues to volunteer at and take pro bono cases for the Los Angeles Gay and Lesbian Center and the HIV & AIDS Legal Services Alliance (HALSA). He has participated as a guest speaker in various immigration-related seminars sponsored by the American Immigration Lawyers Association, National Immigration Project, Harvard University LGBT Policy and Law Conference, Immigration Equality, and Lavender Law Project. He speaks fluent Farsi.

David Cleveland is a staff attorney at Catholic Charities of Washington DC. He is a graduate of the University of Rochester and of Case Western Reserve University School of Law. After being a college instructor in Indonesia for three years, David was a defense attorney for the District of Columbia, where he conducted over 40 civil jury trials. He joined Catholic Charities of Washington DC in 1998, specializing in asylum. In 2004, he was selected out of 275,000 candidates to be the "National Catholic Charities Volunteer of the Year." He served as the AILA representative to the US-CIS Asylum Office from 2003-2006; and as the Chair of the AILA Asylum Committee from 2004-2005.
