### ABOUT THE SPEAKERS

**Christopher Wendt** (Discussion Leader) has been immigration counsel at the Mayo Clinic since 2003. Previously, he was an associate with Butzel Long, P.C. in Detroit, Michigan, advising major corporations in all aspects of business immigration, including assisting with immigrant and nonimmigrant visas, regulatory compliance, governmental investigations, and administrative appeals. In addition, he served as Adjunct Professor of Immigration Law at the Thomas M. Cooley Law School in Lansing, Michigan from 2001 to 2003. Chris obtained his J.D., cum laude, from the University of Michigan in 1998, where he received the Hessel E. Yntema Award for 1997-1998 for performance with distinction in courses and seminars in international and comparative law. He graduated cum laude from Beloit College in 1993, where he studied Government and Russian. He has served as Treasurer of the Minnesota/Dakotas and Michigan Chapters of the American Immigration Lawyers Association. He coordinates the Mayo Clinic Legal Department immigration pro bono project, and currently serves on the board of directors of Southern Minnesota Regional Legal Services and of Legal Assistance of Olmsted County. He was recently named an "Up & Coming Attorney" by Minnesota Lawyer.

**Lisa E.
