### SEMINAR OUTLINE

#### **FIRST Phone Session on March 28 – The Physician Workforce and Expected Immigration Reform Measures**

There should be a very interesting and timely session that could result in attracting a fairly large audience. While we are certainly making some interesting progress toward implementation of Comprehensive Immigration Reform, there is currently a very active and potentially successful initiative to create certain new measures intended to facilitate the immigration of foreign physicians. The whole purpose of this session is to lay forth these reform proposals so as to orient the immigration bar and other interested parties to certain changes that are currently under active discussion. So, this will be a very meaningful opportunity to set forth this reform agenda, to update stakeholders on the progress toward implementation, and to orient practitioners to possible changes that will impact their practices. I very much hope that this introductory session could be heavily marketed as this is the first public program dedicated to this topic.

#### **SECOND Phone Session on April 18 – J-1 Waivers and H-1B Strategies**

While this session will address some issues on J-1 waiver strategy, I would like us to focus mostly on H-1B considerations for physicians and, in particular, strategies for dealing with the H-1B cap. I want to review quite heavily strategies for H-1B exemptions and also the implications of the Hernandez-Schorr correspondence that creates a work-around, of sorts, to the H-1B cap.

#### **THIRD Phone Session on May 2 – Permanent Resident Options for Physicians**

We will be focusing here on employment-based strategies utilized by IMGs in attaining permanent resident status. While we will be talking somewhat about labor certification approaches, I want to focus mainly on non-PERM strategies used both by academic as well as clinical physicians. We will be reviewing various EB1 options, NYSDOT approaches as well as clinical National Interest Waiver cases, and Special Handling strategies. In my opinion, there have been a great many programs dedicated to the PERM process, so I want to use this session to focus on options for permanent residence that do not involve a test of the U.S. labor market.
