This status line will provide information for all cases based on the employer's telephone number. Therefore it is important to know the date that the case was forwarded from the SWA to the DOL to identify a specific case if more than one labor certification is pending for the same employer. The automated system will provide status including the DOL case number and if a FAX number is provided a hard copy of the status information. To discuss a case call 214/767-4989.

FAX NUMBER: 214/767-4788 – No status inquiries will be answered by FAX. Use email inquiry systems. FAX requests to determine if a case has been designated LR or regular will be answered if the case has been pending with DOL for more than 90 days.

MESSAGE: 10 digit employer telephone number or 9 digit tax ID # or 8 digit DOL case number  
DOL will e-mail back job title, salary, case status and DOL case number

If there is a problem in obtaining a status with this method, there is a next level of inquiry. The employer or attorney can send an email request to a special mailbox [daFLCstatus@doleta.gov](mailto:daFLCstatus@doleta.gov). The request should include the DOL case number (if known) and the name of the employer and alien. Responses will only be made after the stated processing time for a case has passed and the case has been at the DOL for more than 90 days. Status inquiries are processed on a quarterly basis.
