### About the Speakers

**David L. Cleveland** (Discussion Leader) is a full-time, volunteer staff attorney at Catholic Charities of Washington DC. He is a graduate of the University of Rochester and of Case Western Reserve University School of Law. After being a college instructor in Indonesia for three years, David was a defense attorney for the District of Columbia, where he conducted over 40 civil jury trials. He joined Catholic Charities of Washington DC in 1998, specializing in asylum. In 2004, he was selected out of 275,000 candidates to be the "National Catholic Charities Volunteer of the Year." He served as the AILA representative to the US-CIS Asylum Office from 2003-2006; and as the Chair of the AILA Asylum Committee from 2004-2005. Articles and chapters by David have been published by AILA, Bender's Immigration Bulletin, and ILW.COM.
