Morrie R. Berez currently is Chief of the USCIS Foreign Trader, Investor & Regional Center Program. His portfolio covers EB-1/2/3 immigrant workers, EB-5 immigrant investors, E-1/2 nonimmigrant traders and investors, and immigration issues relating to international commerce and trade, and Asian Pacific Economic Cooperation (APEC). Morrie started at legacy INS in 1983. Prior to INS he did special investigations for Congress through the Government Accountability Office (GAO) investigating insurance fraud by medical providers, fraud and price fixing by funeral homes and cemeteries, and government procurement fraud. He also worked at the Energy Department, investigating Electric Utilities to identify and deter illegal rate fixing and price gauging in the electric power industry. Prior to Federal Government, he was a law enforcement officer with the Multnomah County (Oregon) Sheriff's Department. Upon graduation from College Morrie served in the Peace Corps in Nigeria, West Africa for 2 years. Morrie did his graduate studies at Ohio University and Duquesne University, completing a Master's program in African Studies and Government, with a minor in linguistics. Morrie has a love of cinema, skiing, crafting pottery, ethnic foods, and intense political discourse. He is married and the father of 3. Two of his kids so far have finished college and are "off the payroll", while his 3rd child is into extreme white water kayaking, snowboarding and rock climbing and is in his final year at Montana State University in Bozeman.

Edward J. Carroll is a graduate of S.U.N.Y.-Binghamton (B.A. 1966) and Brooklyn Law School (J.D. 1969) and was admitted to the Bar in N.Y.S. in 1969 and in Vermont in 1974. Articles authored by Mr. Carroll have appeared in publications of the American Immigration Lawyers Association, the American Bar Association, the Vermont Bar Association and in Canadian publications. From Midway Airport (12 miles): Head north from South Cicero Avenue, and proceed for two miles. Turn right onto I-55 N. Take the US-43 N exit. Bear left at South Lake Shore Drive. Bear right onto the Randolph Street ramp to I-290. Turn left onto the ramp to Wacker Drive. Bear left and head toward East Wacker Drive. Bear right at East Upper Wacker Drive.

From O'Hare International Airport (18 miles): Head west from the terminal, and bear left at International Terminal. Take the I-190 East ramp for two miles. Bear right at I-90 East, and proceed for about five miles. Bear left onto the Express Lanes ramp to Armitage Avenue. Merge onto I-90 Express Lane / I-94 Express Lane. Take the East Ohio Street exit, and continue for one mile. Continue on West Ohio Street. Turn right at North La Salle Boulevard. Turn left at West Upper Wacker Drive. Continue on East Upper Wacker Drive.
